Potential sweepstakes winners will be contacted via the email they provided to enter the giveaway within 48 hours of the close of each Daily Giveaway.

Each potential sweepstakes winner must provide Sponsor with identification and contact information so that Sponsor may verify the potential winner's eligibility and deliver the Prize. If a potential winner cannot or does not satisfy the foregoing condition or any of the conditions described in the "Eligibility" section above, an alternate potential winner will be selected in the same manner as the first potential winner was selected.
